### CONDITIONS OF USE

1. A separate consent will be sought for each production.
2. If consent is given, photographs or recordings from this production may be used at any time in the future.
3. We will not use the personal details or full names (which means first name **and** surname) of any child or adult in a photograph on our web site or in any of our printed publications.
4. We will not include personal e-mail or postal addresses, or telephone or fax numbers on our web site, or in any of our printed publications.
5. If we use photographs of an individual child, we will not use the name of that child in the accompanying text or photo caption.
6. If we name a child in the text of any article or cast list, either printed or on our web site, we will not use a photograph of that child to accompany the article or cast list.
7. We may use photographs with very general labels, such as "the cast of Aladdin".
8. We will only use images of children who are suitably dressed, to reduce the risk of such images being used inappropriately.
9. We will not distribute copies of any video recordings made of any of our performances to anyone other than members and patrons of GADS.
